Directions For Use: For agricultural crops, apply at a rate of one to two gallons of Halo per acre as needed. For soil applications, mix at least one part Halo with two parts water, adding enough water for uniform product delivery. Halo may be placed in furrow or sprayed as a broadcast or top-dress. For foliar application, apply one to two gallons of Halo per acre. Mix Halo with water for a total of at least 15 gallons per acre.
